JOB PURPOSE:

The Chief Mechanic is responsible for overseeing the maintenance, repair, and servicing of all mechanical equipment and vehicles used within the port. This role involves ensuring that all machinery, including cranes, forklifts, trucks, and other heavy equipment, is operating efficiently and safely. The Chief Mechanic will lead a team of mechanics and technicians, manage the maintenance schedule, and ensure compliance with safety and environmental standards.

- 5.1 Maintain detailed records of maintenance and repair activities.
- 5.2 Prepare reports on equipment status, maintenance schedules, and any issues that arise.
- 5.3 Report major mechanical issues to the Port Manager and recommend solutions.
- 6.1 Assist in the preparation and management of the maintenance budget.
- 6.2 Monitor expenses and ensure cost-effective use of resources.
